I acknowledge that NJ FOP licenses plates are a privilege of active membership, and I will conduct myself with the utmost honor, respect and courtesy, so as not to bring negative representation to our organization. Furthermore, should this license plate be requested and issued to a family member (spouse or child), I agree that the license plate will only be for immediate family members that reside at the same domicile as the active member. Should the family member no longer reside at the active member's domicile, the license plates will be surrendered to NJ MVC, and I will notify the NJ State FOP Director of Member Services in writing of the surrender. **I UNDERSTAND THAT FAILURE TO ABIDE BY THESE RULES MAY PRECLUDE ME AND ELIGIBLE FAMILY MEMBER(S) FROM ANY FURTHER LICENSE PLATES, TRANSFERS OR RENEWALS AND MAY LEAD TO THE SUSPENSION OF ALL FOP LICENSE PLATES ISSUED TO ME.** If I am an active FOP member from another state, I must have a letter (on lodge letterhead) date within the past 30 days, emailed from the respective lodge secretary to the NJ State FOP Director of Member Services stating that the member is a due paying member in good standing and must include contact information from such lodge officer.
